Commissioner of the New York City Mayor's Office for People with Disabilities (MOPD)

Nisha Agarwal was appointed Commissioner of the New York City Mayor's Office for People with Disabilities (MOPD) by Mayor Mamdani in February 2026. Throughout her career in public service, advocacy, and law, Commissioner Agarwal has worked to advance equity and expand opportunity for New Yorkers. Commissioner Agarwal has served as Executive Director for Policy and Communications at the NYC Dept. of Health and Mental Hygiene in the Division of Mental Health, Deputy Executive Director for Impact and Senior Advisor at the International Refugee Assistance Project (IRAP), Senior Advisor to the Deputy Mayor for Strategic Policy Initiatives, and led the Mayor's Office of Immigrant Affairs under the de Blasio administration. Commissioner Agarwal this year renewed MOPD's partnership and solidarity with New York's Disability Community by volunteering to serve again as the City agency permittee and partner for the 2026 Disability Justice and Rights Block Party in Union Square Park.
